## **Third Party Fundraising Agreement**

### **Seattle Humane Involvement**

We rely on partners who can work with us as beneficiaries. Although Seattle Humane is unable to copresent or provide planning for events due to the limited size of our staff and our current work plans, once we have a mutually acceptable partnership, we are happy to provide:

- Logos and usage guidelines for your promotional materials
- Listing as co-host of an event on Facebook
- Boilerplate language to use in your promotions and press releases
- Digital photos of Seattle Humane animals (adopted or available for adoption)
- Donation cans, envelopes, or forms and newsletters for use at your event
- Adoptable cats and dogs based on availability

Due to the volume of requests we receive, our own fundraising events, media schedule, and privacy policy, we are **not** able to provide:

- Promotions for your event, including content on our social media channels or marketing onsite.
- Advertising on our website or links to your website.
- Volunteers or staff to help run your event.
- Funding to start up or pay for any of your fees or costs.
- Waived adoption fees, swag, or other items that incur a cost to Seattle Humane.
- Mailing lists, email addresses, or other contact information of our donors or adopters, as this is
  protected information under our privacy policy.

### **Marketing and Promotions of Your Event**

Seattle Humane must pre-approve all promotional materials before distribution, including - but not limited to - fliers and press releases. Materials should not indicate the event is sponsored or presented by Seattle Humane and should specify what portion of event proceeds will be donated to Seattle Humane. "XX% of Proceeds to benefit Seattle Humane" is acceptable language in your communication.

### **Third Party Fundraising Approval**

Generally, the following events will not be approved:

- Events that require significant attendance from Seattle Humane staff and volunteers.
- Events associated with businesses or individuals when there is a potential conflict of interest with Seattle Humane's mission, programs and policies.
- Events that result in the sale, auction, or raffling of animals.

### **Additional Terms**

- 1) The business/organization/individual will not open any bank accounts using Seattle Humane's name or Taxpayer Identification Number (TIN). Any check donations listing Seattle Humane as "Payee" will be forwarded to Seattle Humane for deposit in a Seattle Humane bank account.
- 2) Only donations made directly to Seattle Humane are tax deductible (to the extent permitted by law). Donations made directly to a third party event can thus be used to cover the event's expenses, but these donations are not tax deductible.
- 3) A check for third party event's net proceeds (i.e. gross proceeds less all related expenses), would need to be delivered to Seattle Humane within 10 days of the event's conclusion.
